

**Minutes (Draft)**

**Of the Ordinary Meeting of the Aislaby Middleton and Wrelton Parish Council held at the Village Hall, Wrelton on Tuesday 18<sup>st</sup> February 2020 at 7.30pm**

Present: Cllrs Peirson (chair), Cook, Pickering, Quinlan, Lumley, Baird

1. Apologies: Cllr Wrench.
2. There were no declarations of interest in item on the agenda.
3. a) Minutes of the previous meeting held on 21<sup>st</sup> January 2020 were approved.  
b) No matters arising not on the agenda.
4. Five members of the public were present.
  - (i) Mr. & Mrs. Marsh wished to be updated on the progress of the processing of the status of Back Lane, Wrelton. They also wished to point out that the deeds of their property state that they have a right of vehicular access to the rear of their property from Back Lane. Councillor Peirson updated them on the current position, and stated that he would check with NYCC that this was recognised in their original decision.
  - (ii) Miss Welford wished to bring the problem of excessive speed of vehicles travelling up and down High St./Main St., Wrelton to the attention of the council, and to ask if we could press for this to be dealt with. The council decided to discuss this at the next meeting.
5. Mr. Saggars presented his plan for Vinery Farm. For the current year (2020), the development is limited to the refurbishment/development of the main house and one outbuilding (the cottage).  
Future development of the site (plans for demolition of the current agricultural units and building of residential units, including 'affordable homes', will await the results of various surveys.  
The council considered that there was unlikely to be any objection to Mr. Saggars plans for this year, and were happy to 'wait and see' the results of any surveys done.  
Mr. Saggars was thanked for his willingness to involve the council in his planning, and his attendance.
