Of the Ordinary Meeting of the Aislaby Middleton and Wrelton Parish Council held on line on Tuesday 16th March 2021 at 7.30pm

2. There were no declarations of interest in item on the agenda.
3. a) Minutes of the previous meeting held on 16th February 2021 were approved.
b) No matters arising not on the agenda.
4. Mr. & Mrs. Robinson, of Middleton present.
5. Applications to join the council received from Mr. Adam & Mrs. Charlotte Robinson, of Back Lane South, Middleton, who had joined the meeting as above. They were questioned as to their reasons for wanting to join the PC and invited to continue to take part in the meeting, as visitors initially.

9. General Maintenance/villages

a) Back lane Wrelton – Request from the Planning Inspectorate for a potential virtual meeting on this was agreed by the Council. The chairman has written to offer appearance in support of the application. We await further developments.

10. The Council agreed to invite Mr. John Harland (Ramblers Assoc.) to the May meeting, which should be in the Village Hall, to explain what work has already been done on the DMMO application for Cliff Lane, so that efforts are not duplicated.
Councillor Baird is to continue to checking details of Dams Lane.

11. Dates proposed for Parish Council meetings 2021-2022 were approved.

12. a) Middleton dog waste bin.

Following the PC decision not to fund a fourth bin in Middleton, Stuart Plant has included our suggestion of relocation of the bin down Middleton Carr Lane in the village newsletter, asking for comments and suggestions for a new position. We await his response.

13. Information from the Chairman:

a). Following it's accidental dislodgement, the artillery shell in Aislaby needs recementing. (Between the meeting and the production of these minutes, this has been completed).

b) A request from a Middleton resident to plant flowers on a roadside verge, was responded to by referring them to NYCC Highways Area 4 for permission.

c) Where NYCC Highways have widened the footpath on the A170 through Aislaby, they have been requested to sweep further debris from the path and the gutter. They have agreed.

d) Wrelton phone box is again subject to withdrawal of service. To check that no notice of such withdrawal has yet been posted. At the time of production of these minutes, no such notice has been posted.

e) Mr. & Mrs. Robinson were then asked whether they were still interested in joining the council. They both gave their agreement. The chairman, therefore, agreed to forward the necessary forms to Ryedale District Council on their behalf, and they were welcomed to the Parish Council.
